# Adaptation Practitioners Days – 'What is Adaptation in Practice?'

Scheduled in parallel with the eighteenth meeting of the Conference of Parties (COP 18), on 1-2 December 2012, Adaptation Practitioners Days (APD) brought together Adaptation Practitioners who shared experiences about concrete adaptation actions from the field, and provided answers for the question, "what is adaptation in practice?". It featured a number of presentations that showcased experiences on the ground which were gained from over 10 years of innovative adaptation financing through the Least Developed Countries Fund (LDCF) and Special Climate Change Fund (SCCF). Combined, the two funds have financed over US\$680 million for more than 160 projects in vulnerable LDCs and developing countries. (continued on p. 2)



The first day's events included a high-level opening with the Chief Executive Officer of the Global Environment Facility, Dr. Naoko Ishii and other high-level representatives from UNDP, UNFCCC, World Bank (WB), FAO, the Subsidiary Body for Scientific and Technological Advice, the Least Developed Countries Group, and the Governments of Germany, Tuvalu and Gambia; followed by parallel sessions on Adaptation in Africa and the Middle East, and Asia. In her ntroductory remarks, Dr. Ishii stressed the need for transformational change on a global scale to address adaptation to climate change, which is now an urgent development priority. She called on participants to focus on lessons from the experiences shared by Practitioners that will foster and enable innovation for adaptation. Panel representatives also highlighted the need for "joined-up" action to scale up adaptation financing, integrated adaptation and development objectives, and shared successful best practices to help communities adapt.

During the parallel sessions, Practitioners from Africa, the Middle East and Asia presented their experiences of implementing adaptation in several countries in their regions. They provided concrete examples of how the funds were being used on the ground – namely by developing drought and flood resilient crops, building effective earlywarning systems, promoting community-based adaptation, and strengthening activities in integrated watershed and coastal zone management. Projects were wide-ranging; one Practitioner from Ethiopia highlighted results from the UNDP-supported district-level pilot that has resulted in improved weather communication to farmers in the northeastern region. In Morocco, objectives of the country's WB-supported agricultural and water development strategy known as "Plan Maroc Vert" were outlined; and in Bangladesh, a UNDP-supported project on community-based adaptation, aimed at enhancing resilience in the country's poorest communities, was illustrated.

On the second day, presentations focused on adaptation activities being undertaken to reduce climate risks in vulnerable sectors such as disaster risk and coastal zone management, health, food security and water resources management. As a side event, the awardwinning film "Revealed: The Himalayan Meltdown" (click <a href="here">here</a> to view the trailer), produced by Arrowhead Films and UNDP, was screened. Projects varied from designing catastrophe risk insurances schemes in South Eastern Europe, mangrove replanting in Small Island Developing States, to improving resilience in food production systems. There were engaging discussions and active sharing of lessons learned among the participants.

The APD event was held at the Ezdan Hotel and Suites in Doha, Qatar, and was facilitated by the Global Environmental Facility (GEF) in collaboration with the Secretariat of the United Nations Framework Convention on Climate Change (UNFCCC), and under the sponsorship of the Governments of Germany, the Gambia and Tuvalu.

## New Blog Launched on Climate Information and Early Warning Systems Initiatives in Africa



In the second quarter of 2012, UNDP and GEF, in partnership with eleven countries across Africa (Benin, Burkina Faso, Ethiopia, Gambia, Liberia, Malawi, Sao Tome and Principe, Sierra Leone, Tanzania, Uganda, Zambia), embarked on a programme to strengthen coun-

tries' climate information and early warning systems (EWS) for decision-making, as reported in <a href="Issue 9">Issue 9</a> of the Adaptation Bulletin. The initiatives under this programme aim to generate effective EWS in eleven of the most vulnerable countries in Africa by integrating climate risk knowledge, monitoring and predicting, information dissemination and building national and community response capabilities to act effectively. The <a href="UNDP-EWS Africa Blog">UNDP-EWS Africa Blog</a> was launched to provide updates on the development of these initiatives. # Building Wildfire Management Capacities to Enhance Adaptation of the Vulnerable Mountain Forests of Armenia—Lessons from Recent Experience



This publication was prepared as part of the initiative, "Adaptation to Climate Change Impacts in Mountain Forest Ecosystems of Armenia", financed by the GEF's Strategic Priority on Adaptation and supported by UNDP. It provides background on the unique mountain forests of Armenia, the wildfire situation, and examples of impacts achieved through this initiative. Impacts include building early-response capacities of forest managers,

strengthening institutional cooperation, addressing the root causes of fires, and incorporating climate change risks into forest management. The publication can be downloaded via this <u>link</u>.

## Namibia Wins Momentum for Change Award at COP18

Namibia, along with eight other countries, won the Momentum for Change Award at the18th UN Climate Change Conference (COP18) in Doha, Qatar. Namibia was given the award for implementing the UNDP-supported and GEF-financed project, "Approaching community adaptation to climate change holistically by using multiple coping strate-

gies". The six strategies are implemented in local communities in the five northern regions of Namibia.

#### About the project

Through this community-based adaptation (CBA) project, communities pilot the implementation of six interlinked coping strategies to climate change vulnerability. Project activities focus on awareness-building interventions for climate change, coping strategies and nutritional needs, as well as social mobilization of community members. A participatory approach is used throughout the project cycle – during project planning and development, implementation of activities, and resource mapping. Self Help Groups (SHGs) were formed at the beginning of and during the project allowing community members to take charge of their own development, savings, and lending. In addition, gender mainstreaming and social inclusion approaches are used to ensure that everyone's needs are met and all concerns are addressed, especially for marginalized groups.

Among the various strategies of this project is the innovation and use of the EzyStoves, a revolutionary wood-burning stove developed by local users and the Swedish company Ergonomidesign. It replaces cooking over an open fire, reduces harmful smoke, decreases deforestation, and drastically reduces carbon dioxide emissions. The initiative is a response to communities' concerns over alarmingly high rates of deforestation and increasing respiratory illnesses due to the widespread practice of cooking over open fires. Because EzyStove is fuel-efficient, it lessens women's burdens by reducing fuel wood consumption by two thirds, while simultaneously cutting back toxic emissions by 60 to 80 percent. Users have also reported cleaner cooking environments when using EzyStove since it vastly reduces smoke and soot emissions. The EzyStove greatly contributes to and enhances women's roles in the community since they will now have more time to attend to other daily and more urgent family matters. Namibia's Environmental Investment Fund, a semi-autonomous government agency, is funding a pilot project to bring EzyStove to Katutura - the densely populated township on the outskirts of Windhoek.

The project has also applied a distinct method of Namibia-specific conservation agriculture (CONTILL) to the region. In June 2010 the Siya SHG's first harvest for pearl millet, a staple food in Namibia, increased from an average of 70kg to 570kg per hectare. In addition, the Siya group generated cash income from its maize harvest, and is planning to sell cooking oil extracted from the sunflower harvest. Through the use of CONTILL, food shortages have been lessened and income generating opportunities have grown.

Recognizing that today's youth are tomorrow's leaders, the project's sustainable practices are being integrated into school curricula to ensure wider impacts throughout the country. Children learn about climate change and its impacts, conservation agriculture, soil improvement techniques and micro drip irrigation of vegetables.

The project also aims to influence policy at the local and national level. Upon visiting a project site in 2011, His Excellency Hifikepunye Pohamba, the President of the Republic of Namibia, was impressed with the work carried out by local participants and stated that the projects have the potential to be among the most promising agricultural/adaptation initiatives in the country. The project has been discussed in the Namibian national assembly and is expected to influence government approaches to land management in northern Namibia.

Lessons learned and sustainable adaptive practices have been replicated by neighboring communities as well as other government institutions and NGOs.
