#### WHY THE NAPSNATIONAL ADAPTATION PLANS

- ✓ The process was established in 2010 as part of the Cancun Adaptation Framework to complement the NAPAs,
- ✓ Its designed to support all developing countries, especially the least developed countries (LDCs), in satisfying their medium- and long-term adaptation needs.
- ✓ It is meant to reduce vulnerability, build adaptive capacity and mainstream adaptation into all sector-specific planning,

## Mandate and institutional coordination mechanism for NAP process

#### 1. Mandate

The Ministry of Environment, Climate Change and Natural Resources (MECCNAR) has the Mandated on the NAPs Process,

✓ Mandate strengthened in 2014 with the establishment of the climate change portfolio under it the Climate Change Secretariat

✓ The coordination mechanism for the NAP process is as follows:

CCC; IMCCC

NCC-ANR WG

✓ MECCNAR- Climate Change Secretariat-Climate Change Council-Inter-Ministerial Climate Change Committee-National Climate Committee-Agriculture & Natural Resources Working Group

# 3. Development of NAP road map and NAP formulation

- Conducted stakeholder consultations through the National Climate Committee;
- Conducted a 3 day national workshop to train various stakeholders and launch the NAPs process (July 2015)
- Developed a road map for the process (July 2015) Outdated now
- Established a National NAPs Team and defined their TORs:
  - ✓ The Team constitutes 13 institutions including the private sector
  - ✓ Ministry of Finance as the Chair while MECCNAR and CCS serves as the Secretariat

# Development of NAP road map and NAP formulation

#### CURRENT STATUS

- A NAP Readiness proposal is submitted to the GCF for funding over a three years period- Fresh roadmap,
- Strengthened by the development of NAP-Ag document and roadmap for its implementation
- NAPS project will develop medium and long term adaptation plans,
- Its revised roadmap will include Local adaptation plans (LAPs), climate vulnerability assessments, awareness raising and mainstreaming etc. and develop strategies for the implementation of the NAPS beyond the three years.

### ROLE OF THE CSOs in NAP

- Partnership for implementation
- Advocacy for re-assurance of responsibility
- Supervisory role for oversight
- Ensure inclusiveness (Gender)
- Visibility for knowledge for sharing and sensitization
- Cultural and social acceptance
